BACKGROUND:

State Revenue Sharing Law, ORS 221.770 requires cities to pass an ordinance or resolution each year stating that they want to receive state revenue sharing money. A copy of this ordinance must be filed with the Operations Unit of the Department of Administrative Services prior to July 31, 2012 in order for the City to receive these funds.

I have attached an article from the League of Oregon Cities regarding the 2012 State Shared Revenue Estimates that appeared in the February 2012 LOC Local Focus publication. This article explains each of the state collected taxes the cities are projected to receive based on the 2011-12 legislatively enacted state budget.

SUBJECT: Discuss Proposal from Jim and Tootie Cernazanu regarding encroachment issue

BACKGROUND:

I called Jim Cernazanu on Tuesday, April 25th informing him of the City Council's discussion on his proposal. I explained the City Council's concerns having an easement running through the City's parking lot and having little or no control on who would be using the easement, and the Council's concerns with liability issues as well as the city attorney's research fees. I asked him if he would consider working with the City to correct the issues he has with his existing driveway off Hillcrest Road. He said he would take a look at his driveway and get back to me.

I followed up with Jim on Thursday, May 3, 2012 to see if he had a chance to look at his driveway; he stated he did not; however, he stated he would try to get back to me before Tuesday night's council meeting. Hopefully, we will hear back from Jim before the Council meeting at which time Public Works Director Dave Holland and I will give the Council an update.

grant to complete the US/Main St. & Canyon Blvd., Sidewalk/Beautification

project

BACKGROUND:

We have been informed by ODOT that in 2012, the Transportation Enhancement (TE) and the Oregon Bicycle and Pedestrian Programs (OBPAC) will be combined. There will be one application process, one review process, and one selection process. Successful applicants will be awarded either a TE or an OBPAC grant, or a combination of both – at the discretion of ODOT and the TE and OBPAC grant selection committees.

As you know we received the \$800,000 grant for our US 26 Main St/S. Canyon Blvd. Improvement Project through the TE grant program. Public Works Director David Holland and I would like to apply for this combined grant to improve the section from the Canyon Creek Bridge east to the Hwy 26/395 intersection. The project would be essentially the same project as the US 26 Main St/S. Canyon Blvd. project; bringing as much overhead lines underground as possible, new sidewalks where necessary and new pedestrian lighting. However, this section is very narrow (only a 50' ROW) and could require right-of-way acquisition or eliminate some parking in order to make sidewalk ADA standards. If awarded, this grant would complete our Downtown Improvements project.

I have checked with ODOT and we are eligible to apply for a Notice of Intent (NOI) for the TE+OBPAC combined solicitation. The deadline for NOI submittal is June 6 at 5 p.m. We have budgeted \$18,000 for the match for this project in the 2012-2013 proposed budget in the Street Fund.

RECOMMENDATION:

Public Works Director David Holland said he could estimate the cost of this project by using ODOT's scoping estimates used for our current TE project. We would like permission to submit the Notice of Intent (NOI) by June 6, 2012. Only the NOIs selected by the joint committee will be invited to apply. If we pass round 1, the applications will be due in December 2012 and the projects will be awarded in early 2013.
