- 3. A Press Release regarding the public comment period for the NE Oregon Regional Natural Hazards Mitigation Plan is attached. The final meeting of the Natural Mitigation Plan was September 12th. The purpose of these meetings was to update 2008 mission and goals and review 2008 action items. This Natural Hazard Mitigation Plan was developed through a regional partnership funded by the Federal Emergency Management Agency's Pre-Disaster Mitigation Competitive Grant Program. The Northeast Oregon Regional grant was awarded to support the development of a multi-jurisdictional (Baker, Grant, Union, Wallowa Counties) natural hazard mitigation plans for the region. The region's planning process utilized a four-phased planning process, plan templates and plan development support provided by the Oregon Natural Hazards Workgroup at the University of Oregon. More information and a copy of the 2008 plan can be found online at <u>http://csc.uoregon.edu/opdr/stateplan</u>.

Each organization within the plan will be responsible for adopting the Northeast Oregon Natural Hazards Mitigation Plan. The City of John Day Addendum will be adopted by City Council via resolution once the regional plan and addendum have been pre-approved by the Federal Management Agency. We anticipate scheduling meetings to approve by early 2014.

4. I received a message from Julie Ammann of the Portland District Corps of Engineers. She stated they have completed the preliminary mapping for John Day and Canyon City and would like to come out to discuss results and next step in person regarding the data collections for our flood mapping. They will be here on Thursday, November 21, 2013 at 9 a.m. John Day City Council Chambers, we will meet with Canyon City and Shannon Springer, Grant County Planning Department will also be present.

- 5. ODOT has set Thursday, November 21, 2013 as the date for our next public meeting for our Downtown Sidewalk Improvement project. The purpose of this meeting is to inform the affected property owners about the right-of-way easements that were discussed and approved at our last council meeting. The meeting will be held at the Outpost Pizza & Grill, John Day. ODOT will send a press release and will send notices to the 22 affected property owners.
