BACKGROUND:

At the April 28, 2015 council meeting the City Council adopted Resolution No. 15-732-02, a resolution establishing fees for medical marijuana facilities. Due to a typographical error, Resolution 15-732-02 was numbered incorrectly; Resolution 15-732-02 should have been numbered 15-737-02.

Resolution No. 15-738-03 identifies the numbering error and keeps our resolution numbering system in sequence.

BACKGROUND:

General Code Enforcement Actions

The City of John Day attempts to gain compliance through letters, phone calls, and site visits. Abatement takes more staff time and therefore costs the City and its citizens more money than if compliance is achieved through the other processes. The money that is expended on abatement will most likely not be repaid within a few months or even a few years of the abatement summary bill issued at the end of the process. Therefore, abatement is always a last resort for the City.

Code Compliance Steps Taken for this Property

Since the spring of 2003, the City of John Day has received nuisance complaints regarding the property at 604 NW Bridge Street in John Day owned by Mr. James Goodwin. The nuisances include significant amounts of dead yard debris, weeds, and other noxious vegetation growing and accumulating on the property. In addition two inoperable vehicles are located at the property and a dead/decaying tree is a hazard and a danger to the neighbors and the public.

The following list describes the chronological events regarding this property:

May 30, 2003 letter to James & Christina Goodwin – Violation of Title 8, Chapter 2, Section 4-4: Weeds and Noxious Growth; Violation of Title 8, Chapter 2, Section 4-5A: Scattering of Rubbish;

March 1, 2006 letter to James & Christina Goodwin – Violation of Title 8, Chapter 2, Section 4-5A: Scattering of Rubbish;

April 27, 2006 letter to James & Christina Goodwin - Violation of Title 8, Chapter 2, Section 4-5A: Scattering of Rubbish; May 30, 2007 letter to James & Christina Goodwin – Violation of Title 8, Chapter 2, Section 3B; Violation of Title 8, Chapter 2, Section 4-4;

June 23, 2011 letter to James & Christina Goodwin - Violation of Title 8, Chapter 2, Section 4-4; August 27, 2013 email from James Goodwin; stating he would check into the issue regarding the fire hazard;

October 17, 2013, unattended fire under some trees in drainage at 604 NW Bridge Street, John Day Fire Department responded;

December 12, 2013 email from Police Chief Richard Gray to James Goodwin regarding a vehicles being parked on the property by persons other than the property owner; vehicles were eventually removed by the owner;

June 4, 2014 letter to James & Christina Goodwin - Violation of Title 8, Chapter 2, Section 4-4;

July 30, 2014 letter to James & Christina Goodwin - Violation of Title 8, Chapter 2, Section 4-4;

October 25, 2014, 209 NW 5th Street, (home of Ellen Carlson) limb fell on roof from tree located at 604 NW Bridge Street; caused damage to neighbors home. Homeowners were out of town, but notified of the damage;

April 7, 2015, Police Chief Gray called James Goodwin's father Ralph Goodwin informed him the house had a broken window; father stated James is looking at selling the property;

The John Day City Code 8-2-6-1: Abatement Notice states: Upon determination by the Council that a nuisance as defined in this or any other ordinance of the City exists, the Council shall forthwith cause a notice to be posted on the premises wither the nuisance exits directing the owner or person in charge of the property to abate such nuisance.

As documented in the history of this property compliance has never been achieved. After several letters, Mr. Goodwin did make a little effort to get the property into compliance; however, he failed to succeed. Through multiple notices, site visits, a fire and a limb causing damage to his neighbor's house and patio roof, compliance has never been achieved. The City believes that the only way to gain compliance is to remedy the violations ourselves, because history has proven that Mr. Goodwin has been unable to achieve compliance.

Concurrence

The City Manager, Chief of Police and the Public Works Director of John Day concur with the abatement.

Fiscal Impacts

If declared a nuisance, costs of abatement would depend on what work is done. We would have to determine if a contractor would need to be hired to remove the dying tree, without obtaining a bid from a contractor, costs are hard to determine. The weed and debris abatement can be done by our Public Works Department. We would also have to tow two vehicles. Staff is confident that we have enough funds in the "legal fees" line item to cover most if not all the cost of this project.

Workload Impacts

If declared a nuisance, work load would include the removal of the dead or dying tree(s); towing of two vehicles; removal of overgrown and/or invasive species and debris; and junk.

If no nuisance is declared and if violations continue, City employees will be burdened with the time spent on ongoing violations related to the property.

RECOMMENDATION:

Declare the conditions of the subject property a nuisance, impose a penalty as per section 8-2-7 of the John Day City Code and authorize City Manager Gray to proceed with the abatement process to remove nuisances occurring on the property located at 604 NW Bridge Street, John Day, OR 97845, Assessor's Map 133123CA, Tax Lot 2300 as per John Day City Code 8-2-5-4: Declaration of Nuisance, General Nuisance.

Suggested motion:

I move to declare the conditions of the subject property located at 604 NW Bridge Street, John Day, OR a nuisance, and authorize City Manager Gray to impose a penalty as per section 8-2-7 of the John Day City Code; I also move to authorize City Manager Gray to proceed with the abatement process as per John Day City Code 8-2-6; and, if necessary, allow City Manager Gray the authority to solicit and sign all contracts necessary to hire a contractor to get the work completed.

BACKGROUND:

Included in your council packet is a letter from Phillip Houk, President of the LOC Foundation Board. Mr. Houck, writing on behalf of the LOC Foundation, is seeking support of Oregon cities to continue to fund efforts such as conference and training scholarships that assist the League in its efforts to be the go-to place for and about cities as a dynamic resource hub for advocacy education and best practices.
