BACKGROUND:

The City of John Day applied for and received a Trust Management Services, LLC grant of \$9,170 to purchase and install meeting room equipment in the new fire station's community room.

The specific equipment to be purchased includes 12 eight-foot banquet tables, 96 folding metal chairs, storage carts for tables and chairs, one professional-quality Epson projector, one media cart with built-in outlet and 20-foot power cable, and one 150 inch ceiling-mounted screen.

SUBJECT: Discuss HB 3400 – Measure 91 Local Opt Out Option

BACKGROUND:

On Monday, July 6, 2015 City Attorney Jeremy Green sent a message to his cities regarding HB 3400 that was signed into law by Governor Kate Brown on June 30, 2015. The Act took effect upon passage.

City Attorney Green informs us that HB 3400 contains a "local option" that allows a city council located in a county in which no less than 55% of votes cast were in opposition to Measure 91 to adopt an ordinance that prohibits the establishment of one or more of the following in the area subject to the city's jurisdiction: (1) marijuana processing sites; (2) medical marijuana dispensaries; (3) marijuana producers; (4) marijuana processors; (5) marijuana wholesalers; and/or (6) marijuana retailers. This opt out ordinance must be adopted no later than 180 days after the effective date of the Act - that is by December 27, 2015 (180 days from June 30, 2015).

Jeremy stated he would email us a relatively detailed letter concerning this legislation and that he will be happy to review options with each of the cities after we have an opportunity to review the letter. Unfortunately, Jeremy had a family emergency and won't be back in his office until Monday, July 13th, as such, he did not have time to send the letter.

RECOMMENDATION:

Attached you will find Section 133 of HB 3400 and the 2014 election results of Measure 91 for Grant County. As you can see Grant County voted in opposition to Measure 91 by almost 65%, as such, the City of John Day can adopt an opt out ordinance.

I hope to have more information from City Attorney Jeremy Green by the time of the council meeting.
