BACKGROUND:

The Notice of Public Hearing was published in the May 18, 2016 edition of the Blue Mountain Eagle as required by Oregon Budget Law. The hearing time was published as 7:00 p.m., May 24, 2016. The Council will receive comments at this time on the Fiscal Year 2016-2017 budget.

The public hearing is also an opportunity for any member of the public to comment on or make requests regarding how State Revenue Sharing Funds will be spent in 2016-2017 Fiscal Year beginning July 1, 2016. State Revenue Sharing funds are a share of certain revenues of the State of Oregon that shall be apportioned among and distributed to the cities of this state for general purposes. The John Day Budget Committee approved the proposed budget on April 5, 2016; the minutes of the meeting are attached.

RECOMMENDATION:

Mayor Lundbom will open the public hearing allowing the Council to receive comments on the Fiscal Year 2016-2017 budget and state revenue sharing use within the budget.

The John Day City Council will not formally adopt the budget until the latter part of June so last minute revisions to revenue or expenditure estimates can be incorporated if necessary.

BACKGROUND:

Included in your council packets is Ordinance No. 16-168-01, an ordinance establishing criminal history record check policies concerning applicants for employment, appointed volunteers etc.

The John Day City Council received a copy of Ordinance No. 16-168-01 at your May 10, 2016 council meeting for your review prior to adoption. A notice of availability was posted as per the requirements of Chapter VIII of the John Day City Charter. The ordinance was also posted on the City of John Day's website.

During the city manager's recruitment process, we discovered that the City can do a criminal history check through LEDS purpose code E check, on the city manager applicants only if the city has passed an ordinance that directs the Police Department to run criminal history checks on non-PD city employment applicants. Since we do not have an ordinance that states this we need to adopt one as soon as possible in order to run criminal history backgrounds on non-police department city employees.
