BACKGROUND:

Four committee member positions expire this week: Chris Cronin, Mike Cosgrove, Carolyn Stout, and Mike Miller. There is also one vacancy on the committee.

Mike Cosgrove and Mike Miller have agreed to be re-appointed if the Council wishes. Carolyn Stout and Chris Cronin have declined to serve again.

Dale Rininger has applied to be a new member of the budget committee.

DISCUSSION:

With three vacancies on the committee, we would still have a majority for decision-making purposes but we should seek additional candidates. City Manager Green announced the vacancies on KJDY and requested volunteers through the quarterly newsletter mailed to each home. So far, no volunteers have emerged.

Dale Rininger responded to the KJDY announcement and has applied to the committee. He has a B.S. in Healthcare Management and an MBA, is the manager of the John Day Farmer's Market, and is co-owner of a local business on Main Street.

Appointing Mr. Rininger and re-appointing the returning applicants would still leave two vacancies on the committee. City Councilmembers and City Staff may need to actively recruit individuals to participate.

RECOMMENDATION:
