BACKGROUND

The City approved a project with ODOT to design, obtain necessary right of way and construct sidewalks, storm drain, and bicycle and parking lanes along US395 (West side only, Canyon Boulevard) from SW 6th Avenue to Grant Union High School (MP0.84).

This project was originally intended to design, obtain necessary right of way and construct storm drain only from SW 4th to SW 6th, on US395 (Canyon Boulevard), tying into the existing City storm drain system on SW 4th Avenue, including re-construction of the City storm drain system on SW 4th Avenue (South Side only), if needed.

The City entered into Agreement No. 31224 with ODOT following a motion of the City Council during the July 26, 2016 City Council meeting. The City budgeted \$20,000 for the preliminary engineering phase and was invoiced \$15,504.62 on September 16, 2016. The city was subsequently invoiced in FY16-17 for right of way and utility relocation at \$5,032. The third invoice will be for construction during the FY17-18 fiscal year, which was originally estimated at \$65,728. The City applied for and received a small cities allotment (SCA) grant in the amount of \$50,000 via Resolution 16-761-08 on June 28th, 2016. This grant will cover the majority of the City's match for construction costs. The County will also contribute a portion of the expenses since this project includes two blocks that are outside the city limits.

DISCUSSION

ODOT has developed four options for constructing the sidewalks. All four exceed the amount of money the City budgeted for and was projected to spend. Options 1-3 leave a deficit of \$415K to \$760K to complete the project. Option 4 (separated at-grade sidewalk with a planter strip) will allow us to stay on schedule for our Design Acceptance Package (DAP) and leaves a deficit of \$88K. However, ODOT has found alternative revenue sources to cover \$80K of the cost, so if the City chooses Option 4, we only have to come up with our 10% match of approximately \$9,058.

RECOMMENDATION

Options 1-3 are not financially viable in our current fiscal environment. Representative Bentz is championing for a \$4M increase to the SCA allotments during this legislative assembly. That could create a new revenue source if the city wishes to pursue one of the first three options.

Alternative, the City and County could match funds to cover the cost difference for these options.

The most cost effective solution (Option 4) is also the most achievable with the current budget, but it could require additional maintenance to address silt and planter expenses and it will be difficult to delineate where the highway ends and sidewalk begins during winter months since there will be no curb and gutter.
