The City Council held a public hearing on May 9 and unanimously passed Resolution 17-768-04 to appropriate \$519,000 for the purchase of the Oregon Pine property from DR Johnson Lumber Company. The City has completed its due diligence of the property and is scheduled to sign and close on May 24.

DISCUSSION

The memo enclosed outlines the progress-to-date and next steps in the Oregon Pine property redevelopment.
