The city council approved the City's Strategy for Growth in January 2017. A key pillar of this strategy is to address the housing shortage in John Day by incentivizing new home construction. The City Council authorized the creation of a housing development plan as part of our Strategy for Growth following the April 25, 2017 council meeting. Homebuilders, realtors, lenders, employers and residents, attended this meeting. Their feedback was incorporated into the design of our proposed housing incentive program, which was presented during the city council meeting held September 12, 2017. The City then applied for a Regional Solutions Workforce Housing Initiative (RFI No. DASPS-2839-17) and for a Department of Land Conservation and Development (DLCD) Technical Assistance (TA) grant in the fall of 2017 to finance the program's creation. We received the DLCD TA grant award in December 2017.

In January 2018, we awarded a professional services contract to Elaine Howard Consulting to help with the design of the housing incentive program under ORS 457 – Urban Renewal. The proposed program was presented to the John Day Community Advisory Committee on March 14, 2018. The committee's feedback was incorporated into the urban renewal plan, which was presented to the John Day Technical Advisory Committee (TAC) on May 8, 2018. The TAC recommended the plan be forwarded to the city council for adoption. City staff also presented the plan to the Grant County Court on May 9 and to the John Day Planning Commission for a public hearing on May 24. The Planning Commission recommended the plan for adoption and further recommended the City Council consider amending the Code to allow for the use of the Residential Commercial (RC) zoning designation to allow for housing developments and improvements on unimproved lots currently zoned General Commercial (GC). Minutes for the TAC and Planning Commission meetings are enclosed.

#### DISCUSSION

The documents provided to the city council tonight represent the culmination of 18-months of work by city staff, consultants, community volunteers and the city council. The staff report provides context for the housing plan, report and ordinance scheduled for adoption during the council meeting.

Council should review the enclosed material. Mayor Lundbom will then open the hearing for public comment. After comments are received, Mayor Lundbom will close the public hearing portion of the meeting and council may consider any feedback given.

#### **RECOMMENDED MOTIONS**

The Oregon Parks and Recreation District (OPRD) has opened its 2018 Recreational Trails Program (RTP) grant cycle. Applications are due by 11:59 P.M. on Friday, June 15.

RTPs are national grants administered by OPRD for recreational trail-related projects, such as hiking, running, bicycling, off-road motorcycling, and all-terrain vehicle riding. Yearly grants are awarded based on funds voted on by the U.S. Congress.

RTP funding is primarily for recreational trail projects, rather than utilitarian transportation-based projects. Funding is divided into 30 percent motorized trail use, 30 percent non-motorized trail use and 40 percent diverse trail use. Types of projects include:

- Building new recreation trails, including building trail bridges and installing wayfinding signs.
- Restoring existing trails, including trail bridges and signing.
- Developing and rehabilitating trailhead facilities.
- Acquiring land and permanent easements.
- Water trails.

Project sponsors provide at least 20% of the projects total costs. Eligible matches are cash, force account labor (agency staff), equipment, materials, volunteer labor, donated equipment, donated materials, and federal, state and local grants, or the combination thereof.

#### DISCUSSION

City staff have submitted a letter of intent to apply for the 2018 RTP grant cycle for trail construction at the Innovation Gateway. OPRD received approximately 65 letters of intent. With council approval, staff intend to submit a grant application for approximately \$240,000 to develop a riverfront trail network. Of this, \$180,000 would be grant funded, with the balance provided by the City as cash and in-kind labor and materials. The goals for this network are to improve residents' access to the John Day River within city limits and promote an active-lifestyle community by connecting five neighborhoods to the trail system. They are: Valley View Drive/Ironwood Estates; Charolais Heights/NW Bridge Street; 7<sup>th</sup> Street; 4<sup>th</sup>-5<sup>th</sup>-Canton Street; and Riverside Home Park. The proposed trail system will add to the existing trails at the 7<sup>th</sup> Street Complex and Prospector Trail along the county fairgrounds. When complete, they will provide over four miles of interconnected paved and gravel paths within the city limits, much of which will be ADA-accessible.
