BACKGROUND

In May 2017, the City announced its plans to purchase the Oregon Pine mill site with the intention of converting it to the John Day Innovation Gateway – an 80+ acre innovation center at the heart of John Day. This process has involved multiple meetings with residents and other stakeholders as part of our project advisory committee (PAC) and our technical advisory committee (TAC). During the spring of 2017, we also conducted countywide surveys to help us identify what are the community's overall priorities for the project and for the city.

Through this survey, the community identified Five Bold Steps they wanted us to take. In priority order, they are:

- 1) Build Innovation Gateway
- 2) Build a community recreation center
- 3) Create new housing opportunities
- 4) Provide high speed internet to all area residents
- 5) Conduct a marketing campaign to promote our community

Related discussion focused on: helping bring public and private sector investments together; fostering an entrepreneurial climate; increasing the focus on arts and culture in our community, and; building our internal capacity to achieve these objectives.

DISCUSSION

Over the past two years, we have been actively working to secure funding and develop plans to make that vision a reality. During tonight's city council meeting, we will formally adopt the 2018 Waste Water Facilities Plan Update that will allow us to proceed with engineering for the new wastewater treatment facility.

We will also have an initial presentation from Walker Macy on the design concepts for the Innovation Gateway and the redevelopment of the Oregon Pine property. The Innovation Gateway Project is an integrated community development, transportation and design plan that will envision and support revitalization of the former Oregon Pine mill site and adjacent properties as a dynamic and thriving public space. The Gateway will be connected with public trails through restored floodplain habitat along the banks of the John Day River.

New land uses, including recreational facilities and an exciting vision for the use of reclaimed wastewater, offer significant public investments for John Day's future. These are cohesively linked within the City's Strategy for Growth to maximize innovation and efficiency in water reuse, build partnerships and spur a sustainable and resilient economy that retains and attracts a range of residents and businesses.

Major investments planned for this area include:

- 1) A new wastewater treatment facility that will reclaim 100% of treated wastewater and solids for beneficial reuse
- 2) Revitalization and restoration of one mile of riparian area along the John Day River
- 3) 1.5 miles of new local street networks to service the property
- 4) Networks of trails and sidewalks connecting the community's commercial and residential areas to its parks, streams and rivers
- 5) New commercial buildings and development including office and event space, parking areas and a new aquatics/recreation center

FINANCING

The City has secured \$1.6 million in public sector investment for these projects to-date. Of this, \$869,000 was in long-term, low interest loans for the purchase of Oregon Pine and the construction of the city's first greenhouse; and \$787,500 was in grant funding for economic development and area planning, environmental remediation, construction of the initial trail system on the property and engineering for the new reclaimed water facility. Financing has been provided by six state and one federal agency:

- Oregon Business Development Department (Business Oregon)
- Department of Land Conservation and Development (DLCD)
- Oregon Department of Transportation (ODOT)
- Oregon Department of Environmental Quality (DEQ)
- Oregon Water Resources Department (OWRD)
- Oregon Parks & Recreation Department (OPRD)
- U.S. Economic Development Administration (EDA)

The City is pursuing an additional \$11M in grants and loans for construction of the new wastewater treatment plant during 2019 and 2020 along with approximately \$6M in grants for broadband infrastructure. Additional funding will be requested as needed to complete these projects.

SUMMARY

All the projects presented tonight are in response to public feedback from community surveys – residents telling us what they want for their city – and the efforts of the city council to help revitalize our community. This is a significant undertaking. It will require time, patience and strategic investment to see it through to completion, but I believe it will also lead to significant job growth and reinvestment in our economy. The redevelopment of Oregon Pine and the restoration of our riverfront will be something this generation can look back on as a significant accomplishment that will improve the quality of life of John Day residents for generations to come.

RULES OF ENGAGEMENT

Tonight's presentation is not a public hearing. A public hearing will be held in June or July, following the completion of the design work. This is a public presentation of our initial concepts in order to give our residents and the community an opportunity to review the material developed by our consultants.
