#### BACKGROUND

Staff will review the scope of the FY20 BUILD grant with the city council. The Grant is due May 18th.

#### DISCUSSION

The Better Utilizing Investments to Leverage Development, or <u>BUILD Transportation Discretionary</u> <u>Grant program</u>, provides a unique opportunity for the Department of Transportation to invest in road, rail, transit and port projects that promise to achieve national objectives.

This is a highly competitive program. In 2019, DOT had 666 applications requesting \$10 billion in project value, but only \$900 million available to award, so fewer than 1 in 10 projects were awarded.

Applications are ranked by DOT career staff into one of four categories:

- o Highly recommended
- o Recommended
- o Acceptable
- o Not recommended

The City applied for \$15 million in the 2019 BUILD grant. We were highly recommended for funding but were not awarded the grant. This year's application is expected to be approximately \$17 million and includes additional components not added to the 2019 grant application.

The BUILD grant will help the City achieve its Strategy for Growth – going from population and economic decline to sustainable growth – by helping us build a complete street network and transportation infrastructure that is more welcoming to all users, including walking, biking, driving, automobiles, and public transit.

Specifically, this project will build 3 miles of new street improvements and supporting infrastructure, including:

- Nearly three miles of new arterial streets, collector streets, and local streets;
- One intersection safety improvement project (Charolais Heights);
- One new multimodal bridge for vehicles, bikes and pedestrian access (Third Street);
- One new multimodal bridges for bikes and pedestrians, integrated with parking, trails and public transit stops to tie together the City's disconnected park transportation infrastructure (Hill Family Park).
- Two new downtown parking areas on Main Street.

Benefits of the project include:

- **Improved flood resilience.** The extension of the 7th Street minor arterial will connect the only two functioning bridges in John Day to the north side of the city. Making this connection, combined with the addition of a new passenger bridge at 3rd Avenue, will significantly increase flood resilience and will allow the city to replace its aging bridges, which are in poor condition.
- Workforce housing. This project will open over 40 acres of residential land for housing growth (20 year supply) with the ability to add more than 100 new homes in John Day, our region's largest employment center. Single family housing lots at the Ironwood Estates subdivision and Mahogany Ridge will be sold at fair market value to allow residents to build new homes in our area, and both single-family and multi-family homes will also be constructed by the owners of these developments for lease or purchase. Both housing developers are contributing the 20% match for the street and utility improvements in this areas, making this a public private partnership between local builders/developers and the City of John Day.
- Quality of life improvements. Three new bike/ped bridges across the John Day River along with improved ADA-accessible trails and public transit stops will improve quality of life for residents and enhance visitors' experiences when traveling to John Day by connecting our riverfront parks with downtown and our local heritage sites like Kam Wah Chung. The project also creates connections to new residential neighborhoods, wastewater reuse projects, educational areas, and community gathering places to complete the City's local street network.
- **Economic expansion.** The City has acquired a brownfield site adjacent to the Ironwood Estates subdivision and the John Day Innovation Gateway. This area will be subdivided into 12 industrial lots that will be certified shovel-ready and sold to local businesses to assist with economic expansion. The City has purchased the property and received \$140,000 in brownfield redevelopment funding to assist with the environmental assessment of the property.
- New business growth and riverfront recreation at the Innovation Gateway. The City has partnered with the Priday Family and 1188 Brewing Company to create a new hotel, event center and distillery at the John Day Innovation Gateway. This project includes \$7 million in private investment and is expected to create 32 new jobs. The BUILD grant will construct the turn-lanes from highway 26 into this site and will assist with the parking and driveways needed to access these amenities. The City will build a constructed wetland, beachfront and community gardens at the site to enhance public enjoyment of the property. The plans for this project were awarded the top city project in Oregon in 2019 by the League of Oregon Cities.
- Activating Main Street. The City is actively positioning its downtown corridor as a gateway to the Malheur National Forest and surrounding outdoor recreation areas on public lands. We were awarded the EPA's Recreation Economies for Rural Communities planning assistance grant in 2019 and began planning this year under this program to active our Main Street. Specific projects elements in the 2020 BUILD grant include two downtown parking areas on Main Street within three blocks of our main commercial corridor. This parking will facilitate visitor access to downtown, our heritage sites and the riverfront and will connect to our public facilities in town through improved signage, waypoints and public information displays.

Staff will review the KMZ (digital map) for this project with the city council to discuss any adjustments you wish to make to the scope prior to submission.
