To sum it up they are looking for someone who is good at developing partnerships with the county and other cities, budget friendly, someone who will help the community come together, needs to have a strategic thought process, understand small cities, and they should like the lifestyle and enjoy living here.

GMP Consultants are going to advertise the city manager position nationally. Reaching out to smaller town city managers and administrators. Cities of 30,000 and down. One of the things they'll have to look at very closely is the salary and keeping moving expenses in mind.
