#### **ORDINANCE NO. 18-174-04**

### AN ORDINANCE OF THE CITY OF JOHN DAY, OREGON RATIFYING CREATION OF THE GRANT COUNTY EMERGENCY COMMUNICATIONS AGENCY IN ACCORDANCE WITH ORS 190.085; AND APPROVING A REVISED 9-1-1 JURISDICTION PLAN.

WHEREAS, ORS 190.010 provides that units of local government may enter into agreements for the performance of any functions and activities that any party to the agreement, or its officers or agents, has the authority to perform; and

WHEREAS, under ORS 190.085, each party to an intergovernmental agreement creating an intergovernmental entity must enact an ordinance ratifying the creation of the intergovernmental entity prior to the effective date of the intergovernmental agreement; and

WHEREAS, pursuant to ORS 403.130(9), a revised 9-1-1 jurisdiction plan must be approved, in writing, by the governing body of each public and private safety agencies affected by or providing service in the 9-1-1 service area; and

WHEREAS, the Council desires to (a) declare its intent to create an intergovernmental entity by intergovernmental agreement, (b) ratify creation of the intergovernmental entity, and (c) provide the Council's written approval of a revised 9-1-1 jurisdiction plan.

NOW, THEREFORE, City of John Day ordains as follows:

1. <u>Findings</u>. The above-stated findings are hereby adopted.

2. <u>Short Title</u>. This Ordinance No. 18-174-04 may be referred to as the "Grant County Emergency Communications Agency Ratifying Ordinance" and will be cited and referred to herein as this "Ordinance."

3. <u>Definitions</u>. For purposes of this Ordinance, the following terms and phrases have the meanings assigned to them below:

"Agency" means the Grant County Emergency Communications Agency.

"Agreement" means the intergovernmental agreement between the parties creating the Agency.

"City" means City of City of John Day, an Oregon municipal corporation.

"Council" means the John Day City Council.

"Dispatch Services" means the following: (a) 24-hour per day answering of emergency telephone lines, including, without limitation, 9-1-1 calls, for fire, police, and emergency medical service requests; (b) radio communications with responders regarding emergency and routine police matters; (c) such other services designated by the IGC necessary to carry out Agency's purposes; and (d) certain dispatching and other services for public safety purposes.

"IGC" means Agency's then appointed governing body.

"Law(s)" mean all federal, state, and local laws, statutes, ordinances, and/or regulations directly or indirectly affecting Agency, the Agreement, and/or the Dispatch Services, including, without limitation, the Americans with Disabilities Act of 1990 (and the rules and regulations promulgated thereunder) and ORS chapter 190, all as now in force and/or which may hereafter be amended, modified, enacted, or promulgated.

"Party(ies") means, as of the date of this Ordinance, Grant County, City of Canyon City, City of Dayville, City of Granite, City of John Day, City of Long Creek, City of Monument, City of Mt. Vernon, City of Prairie City, City of Seneca, John Day Rural Fire Protection District, Mt. Vernon Rural Fire Protection District, and Prairie City Rural Fire Protection District.

"Service Area" means all areas lying within the geographic boundaries of Grant County.

4. <u>Intent; Effective Date</u>. The Council hereby declares its intent to create the intergovernmental entity (Agency) to be known as the Grant County Emergency Communications Agency by intergovernmental agreement. The effective date of the Agreement is January 1, 2019.

5. <u>Public Purposes</u>. Agency's purposes include, without limitation, the following: (a) to establish and maintain consolidated public safety communications services; (b) to authorize joint communications services in accordance with ORS chapter 190; (c) to provide improved police, fire, and medical aid service communications within the Service Area and to the Users (as defined in the Agreement); (d) to provide consolidated telephone, radio, and alarm communications services for participating local government units; (e) to establish and maintain such services that will be of substantial benefit to the citizens of the Service Area and the public in general; (f) to negotiate collective bargaining agreement(s) with telecommunicators; and (g) to carry out such other necessary and/or appropriate responsibilities and/or functions as provided by the Parties.

6. <u>Agency Powers; Responsibilities</u>. Agency will have responsibility and authority for public safety communications and functions incidental thereto, including, without limitation, communicating, dispatching, relay, and call transfer in the furtherance of public safety and emergencies within the Service Area. Except as otherwise provided in the Agreement and/or ORS chapter 190, Agency will have the authority to oversee and direct operation and performance of Agency's dispatch center and Dispatch Services and such other responsibilities as may be assigned by the Parties from time to time. Without otherwise limiting the generality of the immediately preceding sentence, and subject to the Laws, Agency will have the following general powers: (a) adopt, through action of the IGC, such bylaws, rules, regulations, standards, and/or policies necessary to carry out the purposes of Agency and/or this Agreement; (b) perform and exercise all powers pursuant to the Laws, including, without limitation, the principal acts of the Parties and ORS chapter 190, which are necessary and/or appropriate to perform or cause to be performed the Dispatch Services; and (c) exercise all powers pursuant to the Laws, including, without limitation, the principal acts of the Parties and ORS chapter 190, which are necessary and/or appropriate to perform or pappropriate to carry out the purposes of Agency and/or appropriate to carry out the purposes of Agency and/or this Agreement.

7. <u>9-1-1 Jurisdiction Plan</u>. Pursuant to ORS 403.130(9), the Council hereby approves the 9-1-1 jurisdiction plan substantially in the form attached hereto as <u>Exhibit A</u>. City Manager is authorized to execute any documents and to take such actions as are necessary to further the purposes and objective of this Section 7. 8. <u>Severability; Corrections</u>. All pronouns contained in this Ordinance and any variations thereof will be deemed to refer to the masculine, feminine, or neutral, singular or plural, as the identity of the parties may require. The singular includes the plural and the plural includes the singular. The word "or" is not exclusive. The words "include," "includes," and "including" are not limiting. Any reference to a particular law, statute, rule, regulation, code, or ordinance includes the law, statute, rule, regulation, code, or ordinance as now in force and hereafter amended. If any section, subsection, sentence, clause, and/or portion of this Ordinance is for any reason held invalid, unenforceable, and/or unconstitutional, such invalid, unenforceable, and/or unconstitutional section, subsection, sentence, clause, and/or portion will (a) yield to a construction permitting enforcement to the maximum extent permitted by applicable law, and (b) not affect the validity, enforceability, and/or constitutionality of the remaining portion of this Ordinance. This Ordinance may be corrected by order of the Council to cure editorial and/or clerical errors. This Ordinance will become effective thirty (30) days after its passage by the Council and approval by the mayor.
