Deliverables do not include the services outside the normal scope of a structural engineering consultant such as:

- Geotechnical Investigations
- Utility locates



- Design of temporary shoring or bracing during construction
- Design of electrical
- Material testing
- Flood-proofing

## Terms:

Scheduling of the project will not take place until receiving signed authorization to proceed.

Payment is requested within 30 days of providing completed design drawings and calculations. Changes required by building officials during the permit application will not incur additional fees.

Correct me if I am wrong. Right now labor is running about 1/3 and materials are running 2/3 of job costs. With the crazy cycle of material prices lately I can not give a solid bid. I see being able to do a solid bid at 36000 and ordering the materials right away then having them sit at the job till able to do construction. This would require \$ up front to cover materials. Another option is to do a set labor cost and the city picks up the material cost. I have no idea what costs are going to do. It would be nice if they went down, but it doesn't seem like they will yet.
