

**AMENDMENT NUMBER 01
GRANT AGREEMENT
SMALL CITY ALLOTMENT PROGRAM
4th Avenue Slide Repair
City of John Day**

This is Amendment No. 01 to the Agreement between the **State of Oregon**, acting by and through its Department of Transportation, hereinafter referred to as "ODOT," and the **City of John Day**, acting by and through its elected officials, hereinafter referred to as "Recipient," entered into on January 16, 2020.

It has now been determined by ODOT and Recipient that the Agreement referenced above shall be amended to extend the termination date by Reinstating this Agreement.

1. **Effective Date.** Upon signature by all Parties and acquisition of all approvals required by law, this Amendment is effective as of January 17, 2022.
2. **Amendment to Agreement.** Deleted items are shown in ~~strikethrough~~ and new items are shown in underline.

a. TERMS OF AGREEMENT, Paragraph 1, Page 1, which reads:

1. **Effective Date.** This Agreement shall become effective on the date this Agreement is fully executed and approved as required by applicable law (the "Effective Date"). The availability of Grant Funds (as defined in Section 3) shall end ~~two (2) years after the Effective Date~~ on December 31, 2022 (the "Availability Termination Date").
3. **Counterparts.** This Amendment may be executed in two or more counterparts (by facsimile or otherwise) each of which is an original and all of which when taken together are deemed one agreement binding on all Parties, notwithstanding that all Parties are not signatories to the same counterpart.
4. **Original Agreement.** Except as expressly amended above, all other terms and conditions of the original Agreement are still in full force and effect. Recipient certifies that the representations, warranties and certifications in the original Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
