**Re:** West 7<sup>th</sup> Street Project

We have completed a review of the Bids submitted on August 18<sup>th</sup>, 2022, at 1:00 PM for the West 7<sup>th</sup> Street Project.

After advertising in the Blue Mountain Eagle and notifying by (17) seventeen contractors by email about the project (5) requested plans and documents. The project had two bid schedules, 'A' was for improvements on 7<sup>th</sup> Street and Patterson Bridge Rd & 'B' was for installing pavers at "The Pit Stop". Of these plan holders Knife River submitted bids on both schedules and Hueckman Contracting submitted a bid on only Schedule 'B'.

Both Contractors turned in the requested proposal, other forms and first tier subcontractors form within the allotted time, therefore valid bids. The instructions to the bidders specified that a bidder could bid on one or both bid schedules and that they would be awarded separately.

We have provided the attached sheet showing a bid tab, the schedule 'A' remained the same as when the bids were publicly opened. Schedule 'B', the totals changed after adjusting the bid unit prices multiplied by the bid number of units (adjusted totals shown in red), causing the apparent low bidder to be in the second position, making Knife River the low bidder by \$655.00.

Knife River stipulated on their proposal that if not awarded Schedule 'A', they did not want to be awarded Schedule 'B'.

Schedule 'A' only had one bidder and pricing is considerably higher than what we normally see on project bids in this area. The City has the option to award Schedule 'A', postpone the award (up to 30 days) or not award and rebid. If rebidding the project, the

scope can also be changed, timelines changed, etc. Although Knife River would withdraw their bid for Schedule 'B', if not awarded Schedule 'A', the two bids received are within less than 0.5% difference. The City could still issue a Notice of Intent to Award for Schedule 'B' to the second bidder if not awarding Schedule 'A', or follow the options noted above about awarding a bid.
