Re: Initial Proposal for On-Going Grant Administration and Project Management Support

I apologize for the succinct format of this proposal. Since January 12, 2023, my firm has put approximately 40 hours into John Day's projects. I am a believer in the City of John Day and have always been impressed with the capital projects on-going. I have worked on your WWTF CDBG project since early-2019 when I was procured as the CDBG Grant Administrator and Environmental Reviewer. I'll attach some brief information on my firm's experience administering federal funds and managing projects. Since 2016, Ducote Consulting has administered federal funds for Seneca, Mt. Vernon, Dayville, Monument, North Powder, Sumpter, Elgin, Haines, Umatilla, Irrigon, and Ontario.

I was procured as a part of the Professional Services On-Call Roster and have a contract with the City to provide support. The task at-hand – taking over for Nick Green in the middle of all of these projects is a monumental task. While I have familiarity with some projects, getting up to speed on all of them takes a lot of time.

Background:

- The only contracts I currently have are the general On-Call contract and the WWTF contract.
- I do not need any changes to the WWTF rates or contract terms. My work on CDBG/USDA sewer
 projects usually look more like what Nick Green did for JD, so I can just take on my more typical
 role there.

Request for Additional Scopes of Work:

- I would need Scopes of Work for each of these projects I'm working on and many of them may need to be reviewed by the funding agencies if the City wants my fees reimbursed through grants.
 - My thought is a general scope of work that covers my tasks with task codes assigned to each different project.
 - The CDBG/USDA work at least will be reimbursed through federal grants.
- For projects other than the WWTF project, I am asking for a rate increase to \$150/hour. The reasons for this request are as follows:
 - I'm going to be working nights and weekends to fit your work into my schedule.
 - This is not my strategy or my grants, I will have to spend a lot of time and energy just to understand what is going on. There's also a lot of risk in that proposition, but I'm willing to take it on.
 - The work is already behind schedule and needs a lot of work in the first few weeks in January and February to get caught up. There are many pressing deadlines.
 - Rate increase retroactive to January 12th when I started working on these issues in earnest. I've dropped a lot and said no to quite at least three new projects in the last two weeks to stay focused on this work in John Day.



- I am happy to provide training to your Staff on how to take over some of my roles. I do not want to be providing full-time service of every City role. I also have capacity to send Judy Vicek, who was previously the accountant for GEODC (now works for me) to come and provide some handson training. I feel with the gaps you guys have in accounting and organization, this could be very valuable.
- I'm open to re-negotiating these terms in June once there is City Staff on-boarded to a level where you want Ducote Consulting to step back from some of the projects. This proposal is intended to be a stop-gap measure for you, not a long-term replacement.
- I am conflicted on your Urban Renewal Agency projects. I am recommending you speak with Brock Eckstein about that work. Brock is an experienced City Administrator in Elgin and Joseph and is currently a consultant working with his wife's law firm Laura Eckstein Law. I sent the City his flier earlier.

Memo to: Mayor Rookstool and the John Day City Councilors

Re: Open position on City Council

I was in attendance at the January 10 Council meeting when it was requested that members of the public send in their thoughts concerning the selection of a new councilor for the open position. Here are my thoughts:

I listened to each of the applicants introduce themselves and describe why they thought they would be qualified to be appointed to the council. When it came time to vote, I was surprised that John Meiling received 3 votes. At that point the only thing I knew about him was his brief verbal presentation to the Council. I do not know John Meiling and have not read his application. In later discussion, Mayor Rookstool read us a portion of his application that did explain more of his thoughts about being on City Council. But, according to further input from council and the audience, it appears that John Meiling does not have a history of doing the things he says he believes in. We heard that he has not run for or held an elective office, has not served on a volunteer board, and has not been a business person or public servant in this community. In other words, John Meiling has not shown himself to be a leader.

When questioned as to why the Mayor and Councilors had voted for Mr. Meiling, the primary reason seemed to be that "change" had been requested by the voters. I believe that the voters were asking for more than change. I believe the voters (myself included) were asking for a leader who could help create change.

To be a good leader in the City of John Day, councilors need to make decisions that they believe are the best for the city. The mayor and councilors need to listen to staff, mentors and outside experts before making decisions. They need to make sure that the information they receive is factual and complete. They need to be sure, to the best of their ability, that the actions they take follow city policy plus state and federal law. It is a hard job, requiring time and commitment.

As was evident at the January 10th meeting, the mayor and council members need assistance from those who have had experience in council meetings and city issues. For example, the former mayor has been appointed to help with issues previously handled by the city managers. Also, we heard from Ms Bass of Solutions that there had been a "mass exodus" of city employees with knowledge and experience.

Since, the appointment of a new councilor would be a short-term position (less than 2 years), I believe it would be helpful to have an individual familiar with public meeting law and current city projects, as well as the city budget. Both Shannon Adair and Chris Labhardt have that experience and proven leadership.

TITLE: Be inclusive - the only path forward

Here is a case of "half a dozen this and six of another." Last November, nearly half of the John Day voters gave their vote of confidence to Shannon Adair (narrowly defeated by only 17 votes) to represent their views on the city council. At the first meeting of the new city council January 10th, half of the council members continued to give their support to Shannon Adair as an applicant to fill the seat vacated by the current mayor. It did not appear that votes for Adair were in any way merely an anti-vote against her opponent. It was overwhelmingly apparent by so many testimonials that Adair holds high respect through her record of giving and competence, benefitting John Day residents. So why didn't the others, the mayor and newly elected council members, recognize her status in the community and act to be inclusive of her (and nearly half the voters)?

If they had supported someone who had an established record of community service and skills required for the position, one could understand their introduction of an unknown applicant. Instead, siding against Adair left 376 voters discounted in favor of an inexperienced person with no proven credits to his name.

There is only one path forward for John Day, and in fact, for the entire county, the country, the world – make a commitment to be inclusive.

This means stop demonizing the "other." Don't give into social cynicism by those who impulsively defame and blame anyone who disagrees with them while never offering real solutions. The only hope is to be certain that all key actors are represented at the table, to be inclusive of ALL the voters' interests. Listen to one another. Then engage in good-faith negotiations. Install Shannon Adair. Thereby, newly elected, you prove your wish to be transparent and independent of any politicized group. If you can do this, there is hope for the city and, therefore, the county to flourish. As goes John Day, so goes Grant County. (Hence, county residents watch your actions with a vested interest.)

To Heather Rookstool, Sherrie Rininger and Ron Phillips:

As the new mayor of John Day, Heather Rookstool, and as new city councilor members, Sherrie Rininger and Ron Phillips, you are now in a position to make positive changes away from the recent political culture of division. Individually or collectively, you have stated your desire to build trust in local leadership through "respect."

I must be candid and transparent with you. Those who did not vote for you (and county residents who follow the functionality of John Day leaders with vested interest) are challenged to accept the sincerity of your words because several loud voices campaigning for your candidacies publicly direct personal attacks against the character of individuals you opposed on the ballot. Without publicly denouncing such personal attacks, people were left to wonder if you were sanctioning their divisive behavior. So, there is work to be done to clarify where your loyalties are aligned now that you are obligated to represent all the voices of your constituency. That said, there is a path forward that can work for each of you, as well as for the entire city (and county) community.

You have already taken the first step by assessing the budget work of your predecessors. The recent very positive audit report made it clear that you are standing on the shoulders of competent, economically stable, former managers. Former accusations about city representatives being guilty of manipulation of money were just not true. The numbers prove that. You have a lot of good ground to build upon.

You are not obligated to any group or person who resorts to bad behaviors in order to undermine reconciliation with those who oppose your views. Reconciliation is how to begin building respect and dignity in the public forum. People want leaders who understand that we actually need each other as critics. We all make assumptions that support our biases. "The others" see those assumptions better than us. Pointing out the common ground along with points of differences about issues (without personal attacks) brings clarity about paths forward in the form of creative policies. A resulting good policy is strengthened, not weakened, by respectful counter arguments. The community wins; and opposing leaders can walk down Main Street and proudly greet one another. Again, more than just being civil, leaders at the table need to realize that opposing minds truly need each other for the well-being of their community. The goal should not be to load the council with all like-minded representatives. Rather, appoint the most competent, experienced, honest, open-minded applicants to ensure a balance of power that will produce policies based on the best ideas. This would represent a true political victory for the whole community.

Some ideas for rules for engagement:

- Acknowledge a common "good will" with "the others" who also deeply care about the community; don't target perceived failures. Neither side has been perfect, and people deserve opportunities to learn.
- When needing to counter an opinion, target the specifics of an idea (not the person), but then, always offer alternate solutions. In other words, offer "policy" do not attack character as a means to weaken opposing ideas.
- A diet of contempt and hateful voices will poison your heads and hearts. Make a commitment to avoid sources of demonizing podcasts, vitriolic social media platforms, news outlets lacking broad representation of voices. Speak to people face-to-face to find "that pulse" of your community.

- "Damning views dams discussion." Upon making your case based on your biases, make a commitment to remain open-minded until all arguments are completed. In other words, see yourself in "the other" to encourage discussion. Suppress the emotional thought, "I'm above you" to avoid a failure to listen. To check yourself, repeat to your opponent what you heard them say.
- Everyone in the room (from the mayor and all councilors to commenters) would help bring needed change by consideration of these (and similar) ideas.

You ran for office because you strongly want to see John Day and, consequently, Grant County economically stable, safe, sustainable, prosperous for our small businesses, and thriving for families. Hopefully, you recognize that being inclusive of all who share these mutual goals is how to bring needed changes in our political environment. To begin this process, appointing Shannon Adair to the remaining council seat would be a wise step in providing continuity (experience), competence and expertise to the council. In doing so, you would be making a statement of loyalty and obligation to the entire community.
