The City Council meeting was called to order at 6:30 pm.

Councilor Bush made a motion to approve the consent agenda as published. The motion was seconded by Councilor Swank and passed unanimously.

Agenda Item No. 7—Ordinance No. 25-03; An Ordinance Amending Title 7, Chapter 4 of the John Day City Code, Which Chapter Concerns the City of John Day Water System Utility Rules and Regulations.

To Address Temporary Water Services, Including Fees and Charges Concerning Temporary Services; and Declaring an Emergency.

No public comments were made.

Councilor Bush made a motion to read Ordinance No. 25-03 by title only. The motion was seconded by Councilor Labhart and passed unanimously.

Councilor Bush made a motion to approve Ordinance No. 25-03 as read by title only. The motion was seconded by Councilor Swank and passed 6-1 with Councilor Labhart being opposed.

Councilor Labhart voted against this because he believes it is not fair to individuals that leave for 6 months a year and have to continue to pay for water and sewer services even if water services are shut off.

This is being declared an emergency so it can be implemented in July 2025. No public comments were made.

Councilor Bush made a motion to read Ordinance No. 25-04 by title only. The motion was seconded by Councilor Swank and passed unanimously.

Councilor Bush made a motion to approve Ordinance No. 25-04 as read by title only. The motion was seconded by Councilor Phillips and passed 6-1 with Councilor Labhart being opposed.

SUBJECT: Amendment #1 to the Keller & Associates scope of work for the Wastewater Treatment Plant Design

BACKGROUND:

The amendment has four separate components to it with the following summary;

- 1. Updating verbiage of the contract language to Keller's responsibilities with the removal of Kennedy Jenks from the contract. This information has no additional cost to the owner.
- 2. Due to schedule and budget constraints for the changes from KJ, our team found the only way we could complete the changeover is to minimize project management and operational fees without increasing costs to the City. This option is to change the task billing from hourly to lump sum. This change has no additional cost to the owner if approved.
- 3. Updating the scope of work to include design for solids handling. Task 2.2.1.2 specifically outlined that this work was previously not included in the original contract due to ongoing negotiations with a landowner at the time of the contract agreement for land application currently used. The amendment fee accounts for the work that is required as part of the project going forward to handle all solids on site. Prior work on this aspect has been donated to the City at no additional cost.
 - a. Please note, regardless if an agreement was completed with the landowner, there would have been additional costs to the project either way. It would have been simply directed towards whatever agreement process was chosen.
- 4. Updating the scope of work to include final design of the Tertiary Filter. The contract assumed a design to 30% not knowing if the filter would be required for either water reuse or for the WPCF permit. Due to the strict limits of the WPCF for Nitrate levels, the filter is required for the WWTP in order to meet effluent limits. Therefore, the design will be extended from 30% to final construction documents. The amendment fee is accounting for this additional work.



FINANCIAL IMPACT: The total cost of the scope of work amendment is an additional \$353,500.00

Nature of Amendment:

Flagline Engineering (Flagline) joined Keller Associates, Inc. (Keller or Engineer) and initiated an assignment of contract consistent with Section 6.06 of the original contract dated 8/14/24. The assignment was approved by the City of John Day on 1/29/25. Beginning February 1, 2025, all outstanding contract obligations were formally assigned to Keller.

This amendment updates the design to include a tertiary filter (originally only scoped up to 30% design) to now extend to the 100% design to address the nitrate levels within the WPCF permit. The original intent of the tertiary filters was provided as a potential requirement for the recycled water use and possibly to address the requirements for the WPCF permit. The City wanted to include provisions for a potential future retrofit that would readily accommodate recycled water. After initial design, it was determined that the filter is recommended to meet the WPCF discharge limits for nitrates regardless of the recycled water needs .

The original scope of work (see Task 2.2.1.2) also did not include evaluations or design for dewatering or sludge handling. The reason for this was at the time of scoping, there were questions about the availability of land for land application. There was an assumption that a screw press would be used potentially for future land application methods, but the negotiation of the private land application was under review at the time of scoping the project. It was decided that, this evaluation and design would be reviewed at a later date once more information was available to the City and Engineer.

In addition to adding filter and sludge storage project elements, this amendment changes the compensation method from an hourly rate basis to a lump sum basis to facilitate schedule requirements of the project and reduce administrative costs. There are no increases to project budgets resulting from this change from Hourly to Lump Sum for Tasks 1-4 and 5.4. Budget increases presented herein are to address added project elements.

Other items noted within this amendment are updated verbiage for the project based on current knowledge or housekeeping items related to the transition from Flagline to Keller that have no financial

implications. Tabulation of financial changes will be summarized in the Compensation Summary at the end of the document.

Modifications to the Prime Agreement

- ❖ ADD the following to Section 2.02 (Owner's Instructions Regarding Bidding/Proposal and Front-End Construction Contract Documents):
 - D. Owner will work with Engineer and Oregon Department of Environmental Quality to assess if the tertiary filter will be an optional additive bid item or if it will be included in the base bid for construction. In making this decision, the Owner will consider their budget and the ability to meet the plant's permit requirements. Additional details are noted within Task 5.4 description updates.

DEQ-CWSRF will need to adopt the CDBG Environmental prior to construction.

2. PROJECT FUNDING (TASK 2)

This has been the most successful fundraising cycle for the John Day wastewater treatment plant project ever. The City has successfully lobbied the state and federal government to earmark funds for the John Day wastewater treatment plant project. As a part of SB-5531, the City has received the single largest



grant for the treatment plant ever. This funding will be earmarked entirely for the construction of the new wastewater treatment plant.

On the federal level, \$4.5m is in process with the federal legislature and budget process (FY26). \$1m request from the federal legislature for FY25 is in limbo. However, the larger of the two requests has advanced.

This cycle's success is largely in part to the efforts of City Manager Bethal and Mayor Rininger's tireless lobbying and advocacy for the City. When I started fundraising for this project, the state and feds were not interested in further support of this project until there was some stability in city leadership.

Oregon Senate Bill 5531, enrolled and signed by legislature as of 7/2/25:

SECTION 25. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$5 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

(2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the OBDD Economic Development Distributions Fund established under section 28, chapter 748, Oregon Laws 2017, for distribution to the City of John Day to construct a new wastewater treatment plant.

(3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that wastewater treatment systems are an integral part of the commercial and industrial infrastructure of this state, and improving wastewater treatment will promote economic development and watershed health.

CHAPTER	

AN ACT

Relating to lottery bonds; creating new provisions; amending ORS 285B.551 and sections 4 and 10, chapter 906, Oregon Laws 2009, and section 28, chapter 748, Oregon Laws 2017; repealing section 45, chapter 599, Oregon Laws 2023; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 285B.551 is amended to read:

285B.551. (1) Pursuant to ORS 286A.560 to 286A.585, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds:

- (a) To provide financial and other assistance, including but not limited to loans and grants, to municipalities, ports and other persons and entities in accordance with the laws governing use of moneys in the Special Public Works Fund created by ORS 285B.455, the Water Fund created by ORS 285B.563, the Safe Drinking Water Revolving Loan Fund created by ORS 285A.213, the Oregon Port Revolving Fund created by ORS 285A.708, the Brownfields Redevelopment Fund created by ORS 285A.188, the Oregon Business Development Fund created by ORS 285B.092 and the Marine Navigation Improvement Fund created by ORS 777.267.
 - (b) To fund Oregon's share of the costs of the Columbia River channel deepening project.
- (c) To fund Oregon's share of the costs of studies and ecosystem restoration projects in the lower Columbia River estuary designed to improve habitat for listed endangered or threatened species of Columbia River anadromous salmonids.
 - (2) The use of lottery bond proceeds is authorized based on the following findings:
- (a) The financial and other assistance to municipalities, ports and other persons and entities will assist in the establishment and expansion of businesses in Oregon and in the construction, improvement and expansion of infrastructure, community and port facilities and other facilities that comprise the physical foundation for industrial and commercial activity and provide the basic framework for continued and expanded economic opportunities and quality communities throughout Oregon.
- (b) The Columbia River channel deepening project is necessary to allow newer, larger steamships access to Oregon and Washington deep draft ports. A deeper shipping channel will allow the Columbia River to continue as a world leader in agricultural exports and as a key trade corridor for farms and businesses throughout Oregon and the region.
- (c) Such financial and other assistance to municipalities, ports and other persons and entities and the deepening of the Columbia River channel will therefore promote economic development

within this state, and thus the use of net proceeds derived from the operation of the Oregon State Lottery to pay debt service on lottery bonds issued under this section to provide such financial and other assistance to municipalities, ports and other persons and entities and to pay a portion of the costs of deepening the Columbia River channel is an authorized use of state lottery funds under section 4, Article XV of the Oregon Constitution, and ORS 461.510.

- (d) The current lower Columbia River estuary habitat for listed endangered or threatened species of Columbia River anadromous salmonids could be improved through ecosystem restoration projects. The use of the Oregon State Lottery to pay debt service on lottery bonds issued under this section to pay for studying how the estuary could be improved and to pay for ecosystem restoration projects are authorized uses of state lottery funds.
- (3)(a) The aggregate principal amount of lottery bonds issued pursuant to subsection (1)(a) of this section for financial and other assistance to municipalities, ports and other persons and entities may not exceed the sum of [\$416,226,252] \$436,226,252 and an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs. The aggregate principal amount of lottery bonds issued pursuant to subsection (1)(b) of this section for the Columbia River channel deepening project may not exceed the sum of [\$17.7] \$32.7 million and an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (b) The Oregon Department of Administrative Services may not request the issuance of lottery bonds under subsection (1)(b) of this section until the Director of the Oregon Business Development Department determines that a final environmental impact statement has been issued and a record of decisions has been submitted to Congress by the United States Army Corps of Engineers, Congress has authorized the Columbia River channel deepening project, and the Washington sponsors' shares of the costs of the Columbia River channel deepening project have been committed.
- (4) The net proceeds of lottery bonds issued pursuant to subsection (1)(a) and (b) of this section shall be deposited in the Economic Infrastructure Project Fund, which is hereby established in the State Treasury separate and distinct from the General Fund. Interest earned by the Economic Infrastructure Project Fund shall be credited to the fund. All moneys in the Economic Infrastructure Project Fund are continuously appropriated to the Oregon Business Development Department for any purpose for which moneys in the Special Public Works Fund created by ORS 285B.455 may be used, any purpose for which moneys in the Water Fund created by ORS 285B.563 may be used, any purpose for which moneys in the Safe Drinking Water Revolving Loan Fund created by ORS 285A.213 may be used, any purpose for which moneys in the Oregon Port Revolving Fund created by ORS 285A.708 may be used, any purpose for which moneys in the Brownfields Redevelopment Fund created by ORS 285A.188 may be used, any purpose for which moneys in the Oregon Business Development Fund created by ORS 285B.092 may be used and any purpose for which moneys in the Marine Navigation Improvement Fund created by ORS 777.267 may be used. The Director of the Oregon Business Development Department shall allocate the moneys deposited in the Economic Infrastructure Project Fund for the purposes described in this subsection in accordance with the priorities developed by the Oregon Business Development Commission in accordance with ORS 285A.020. However, the director shall transfer from the Economic Infrastructure Project Fund and deposit into the Channel Deepening Account of the Marine Navigation Improvement Fund the proceeds of any lottery bonds sold to finance a portion of the costs of the Columbia River channel deepening project. Upon determining the relative allocation of moneys deposited in the Economic Infrastructure Project Fund among the purposes described in this subsection, the director shall transfer from the Economic Infrastructure Project Fund, and deposit into each of the other funds described in this subsection, the amounts so allocated. Notwithstanding any other provision of law governing the funds described in this subsection, the funds described in this subsection may be credited with moneys transferred from the Economic Infrastructure Project Fund by the director in accordance with this subsection.
- (5) The aggregate principal amount of lottery bonds issued pursuant to subsection (1)(c) of this section for the costs of studies and ecosystem restoration projects in the lower Columbia River estuary may not exceed the sum of \$750,000 and an additional amount estimated by the State

Treasurer to be necessary to pay bond-related costs. The net proceeds of lottery bonds issued pursuant to subsection (1)(c) of this section shall be deposited in the Oregon Business, Innovation and Trade Fund created by ORS 285A.227 and may be used only for the Oregon nonfederal share of United States Army Corps of Engineers Columbia River estuary projects authorized by Congress prior to August 9, 2001. The director may not request the issuance of lottery bonds under subsection (1)(c) of this section until Congress and Washington have authorized their respective shares of the costs of the studies and ecosystem restoration projects in the lower Columbia River estuary.

- (6) The proceeds of lottery bonds issued pursuant to this section may be used only for the purposes set forth in this section and for bond-related costs.
- SECTION 2. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$10 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Oregon Business Development Department for deposit in the Levee Project Grant Fund established in ORS 285B.421, for the purpose of providing grants under ORS 285B.420 for levee projects as defined in ORS 285B.410.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Levees are an integral part of the commercial and industrial infrastructure of this state; and
- (b) The inspection, accreditation, certification and repair of levees will promote economic development within this state.
- SECTION 3. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$10 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Oregon Business Development Department for deposit in the Brownfields Redevelopment Fund established in ORS 285A.188 for the purposes described in ORS 285A.185 and 285A.188.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Redevelopment of industrial-zoned brownfields improves the economy by returning the assessed value of the properties to the real market value for property taxation purposes; and
- (b) The projects made possible through increased funding to evaluate, clean up and redevelop brownfields properties create jobs and further economic development.
- SECTION 4. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Department of Education, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$15 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Department of Education for deposit in the Connecting Oregon Schools Fund established in ORS 276A.424, for providing matching funds for federal moneys received by school districts, education service districts, public charter schools or a consortium that consists of any combination of school districts, education service districts and public charter schools, for the purpose of providing broadband access to eligible education facilities in this state.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Assisting education facilities with matching funds promotes expansion of access to high-speed broadband for public education; and
- (b) Providing financial assistance to education facilities for building connections to broadband infrastructure will enhance community efforts to promote economic growth.
- SECTION 5. Section 4, chapter 906, Oregon Laws 2009, as amended by section 3, chapter 624, Oregon Laws 2011, section 19, chapter 786, Oregon Laws 2013, section 15, chapter 121, Oregon Laws 2014, section 37, chapter 812, Oregon Laws 2015, section 4, chapter 66, Oregon Laws 2016, section 7, chapter 748, Oregon Laws 2017, section 7, chapter 671, Oregon Laws 2019, section 4, chapter 682, Oregon Laws 2021, and section 9, chapter 599, Oregon Laws 2023, is amended to read:
- **Sec. 4.** (1) Pursuant to ORS 286A.560 to 286A.585, at the request of the Oregon Department of Administrative Services, after the department consults with the Housing and Community Services Department, the State Treasurer is authorized to issue lottery bonds for the Housing and Community Services Department to provide financial assistance to aid in the acquisition, **stabilization**, renovation or maintenance of properties with project-based federal rental assistance contracts, public housing undergoing significant recapitalization or publicly supported housing as defined in ORS 456.250, or to preserve the affordability of manufactured dwelling parks.
 - (2) The use of lottery bond proceeds is authorized based on the following findings:
- (a) Individuals who are at risk of homelessness or who otherwise pay a disproportionate share of income for housing increase their potential for self-sufficiency, and use proportionately fewer community-funded resources when they are provided a stable housing environment.
 - (b) Having housing for at-risk populations is essential to Oregon's healthy economic growth.
- (3) The aggregate principal amount of lottery bonds issued pursuant to subsection (1) of this section may not exceed the amount of [\$108,801,718] \$161,301,718 plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs as defined in ORS 286A.560.
- SECTION 6. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Water Resources Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$8 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Water Resources Department for deposit in the Water Supply Development Account established in ORS 541.656, for providing grants or loans to evaluate, plan and develop in-stream and out-of-stream statewide water development projects.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Having adequate drinking water systems, irrigation, drainage and healthy ecosystems enhances community development and supports Oregon's economic growth; and

- (b) Assisting local governments to mitigate losses resulting from reduced water supply for irrigation and retirement of water rights will enhance community efforts to facilitate and promote economic growth.
- SECTION 7. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$20 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the OBDD Economic Development Distributions Fund established under section 28, chapter 748, Oregon Laws 2017, for distribution to the Urban Flood Safety and Water Quality District for levee system improvements along the Columbia River from Sauvie Island to the Sandy River in Troutdale.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Levees are an integral part of the commercial and industrial infrastructure of this state; and
- (b) The inspection, accreditation, certification and repair of levees will promote economic development within this state.
- SECTION 8. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$10 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Oregon Business Development Department for deposit in the Housing Infrastructure Project Fund established under section 3, chapter ____, Oregon Laws 2025 (Enrolled House Bill 3031), for the purpose of providing grants to support key community infrastructure investments including transportation, water, wastewater and stormwater infrastructure that will result in affordable housing for households with very low, low or moderate income.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) Individuals who are at risk of homelessness or who otherwise pay a disproportionate share of income for housing increase their potential for self-sufficiency, and use proportionately fewer community-funded resources, when they are provided with a stable housing environment; and
- (b) Having housing for at-risk populations is essential to Oregon's healthy economic growth.
- SECTION 9. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department and subject to subsection (3) of this section, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$20 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Oregon Business Development Department for deposit in the Container Port Improvement Fund established under section 10 of this 2025 Act for the purpose of providing grants for capital improvement projects to ensure that Oregon ports can continue to provide container service.
- (3) Lottery bonds authorized under this section may not be issued unless the Oregon Business Development Department certifies that the Port of Portland has executed an agreement with an entity to operate the Terminal 6 container terminal.
- (4) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that financial and other assistance to municipalities, ports and other persons and entities will assist in the establishment and expansion of businesses in this state and in the construction, improvement and expansion of infrastructure, community and port facilities and other facilities that comprise the physical foundation for industrial and commercial activity and provide the basic framework for continued and expanded economic opportunities and quality communities throughout this state.
- SECTION 10. (1) The Container Port Improvement Fund is established in the State Treasury, separate and distinct from the General Fund. Interest earned by the Container Port Improvement Fund must be credited to the fund. The Container Port Improvement Fund consists of moneys deposited in the fund under section 9 of this 2025 Act and may include moneys appropriated, allocated, deposited or transferred to the fund by the Legislative Assembly or otherwise and interest earned on moneys in the fund.
- (2) Moneys in the fund are continuously appropriated to the Oregon Business Development Department for disbursement for the purposes set forth in section 9 of this 2025 Act.
- SECTION 11. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$10 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Oregon Business Development Department for deposit in the Industrial Site Loan Fund established under section 12, chapter ____, Oregon Laws 2025 (Enrolled House Bill 2411), for projects related to industrial lands readiness activities.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that industrial development that provides new traded sector jobs reinforces the economies of local and regional communities and contributes to Oregon's economic recovery.
- SECTION 12. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the City of Beaverton, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$3 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the ODAS Economic Development Distributions Fund established under ORS 461.553, for distribution to the City of Beaverton for construction of an affordable housing project for seniors.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks,

beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:

- (a) The Meadowlark Senior Housing project will help to satisfy Oregon's need for affordable housing;
- (b) Having housing for at-risk populations is essential to Oregon's healthy economic growth; and
- (c) A severe shortage of affordable housing exists in Oregon, and market indicators demonstrate a growing gap between the supply of and the demand for affordable housing.
- SECTION 13. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Museum of Science and Industry, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$5 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the ODAS Economic Development Distributions Fund established under ORS 461.553, for distribution to the Oregon Museum of Science and Industry for construction of OMSI District infrastructure to support affordable housing and mixed-use development.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
 - (a) The OMSI District project will help to satisfy Oregon's need for affordable housing;
- (b) Having housing for at-risk populations is essential to Oregon's healthy economic growth; and
- (c) A severe shortage of affordable housing exists in Oregon, and market indicators demonstrate a growing gap between the supply of and the demand for affordable housing.
- SECTION 14. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Mid-Willamette Family YMCA Veterans Housing, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$3.361 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the ODAS Economic Development Distributions Fund established under ORS 461.553, for distribution to the Mid-Willamette Family YMCA Veterans Housing for construction of an affordable housing project for veterans.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the following findings:
- (a) The Albany Veterans Apartments project will help to satisfy Oregon's need for affordable housing;
- (b) Having housing for at-risk populations is essential to Oregon's healthy economic growth; and
- (c) A severe shortage of affordable housing exists in Oregon, and market indicators demonstrate a growing gap between the supply of and the demand for affordable housing.
- SECTION 15. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$2.861 million in net pro-

ceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the OBDD Economic Development Distributions Fund established under section 28, chapter 748, Oregon Laws 2017, for distribution to Morrow County for the Clean Water Consortium for promoting access to safe drinking water.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that safe drinking water is an integral part of the commercial and industrial infrastructure of this state, and essential for economic development.
- SECTION 16. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Water Resources Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$6.5 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.
- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Water Resources Department for deposit in the Water Resources Department Water Supply Fund established in section 10, chapter 906, Oregon Laws 2009, for distribution to the City of Oregon City to construct the second Henrici Water Reservoir.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that water reservoirs are an integral part of the commercial and industrial infrastructure of this state, and essential for economic development.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the OBDD Economic Development Distributions Fund established under section 28, chapter 748, Oregon Laws 2017, for distribution to the City of Eugene to construct a wastewater collection system to prepare industrial land for development.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that wastewater treatment systems are an integral part of the commercial and industrial infrastructure of this state, and improving wastewater treatment will promote economic development and watershed health.

- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that health care facilities are necessary components of a climate that facilitates and encourages economic development.
- SECTION 34. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Oregon Business Development Department, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$3 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the department for deposit in the OBDD Economic Development Distributions Fund established under section 28, chapter 748, Oregon Laws 2017, for distribution to the Confederated Tribes of Warm Springs for work on the existing drinking water treatment plant filtration system.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that safe drinking water is an integral part of the commercial and industrial infrastructure of

this state, and improving water treatment will promote economic development and watershed health.

SECTION 45. (1) For the biennium beginning July 1, 2025, at the request of the Oregon Department of Administrative Services, after the department consults with the Department of Transportation, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.560 to 286A.585 in an amount that produces \$45 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Department of Transportation for deposit in the DOT Economic Development Distributions Fund established under ORS 461.557, for distribution to the Hood River-White Salmon Bridge Authority to support the Hood River-White Salmon Interstate Bridge replacement project.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that a safe, efficient and reliable transportation infrastructure supports the long-term economic development and livability of this state.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Department of Transportation for deposit in the DOT Economic Development Distributions Fund established under ORS 461.557, for distribution to the Hood River-White Salmon Bridge Authority to support the Hood River-White Salmon Interstate Bridge replacement project.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that a safe, efficient and reliable transportation infrastructure supports the long-term economic development and livability of this state.

SECTION 47. (1) For the biennium beginning July 1, 2029, at the request of the Oregon Department of Administrative Services, after the department consults with the Department of Transportation, the State Treasurer is authorized to issue lottery bonds pursuant to ORS 286A.580 to 286A.585 in an amount that produces \$30 million in net proceeds for the purposes described in subsection (2) of this section, plus an additional amount estimated by the State Treasurer to be necessary to pay bond-related costs.

- (2) Net proceeds of lottery bonds issued under this section must be transferred to the Department of Transportation for deposit in the DOT Economic Development Distributions Fund established under ORS 461.557, for distribution to the Hood River-White Salmon Bridge Authority to support the Hood River-White Salmon Interstate Bridge replacement project.
- (3) The Legislative Assembly finds that the use of lottery bond proceeds will create jobs, further economic development, finance public education or restore and protect parks, beaches, watersheds and native fish and wildlife, and is authorized based on the finding that a safe, efficient and reliable transportation infrastructure supports the long-term economic development and livability of this state.

SECTION 48. Section 45, chapter 599, Oregon Laws 2023, as amended by section 6, chapter 104, Oregon Laws 2024, is repealed.

SECTION 49. (1) Prior to requesting the issuance of lottery bonds pursuant to this 2025 Act, the Oregon Department of Administrative Services shall review each authorized use of

lottery bond proceeds and determine whether the recipient is ready to expend the proceeds for the authorized use.

- (2) If the department determines that a recipient is not ready to expend the proceeds for an authorized use, the State Treasurer may not issue lottery bonds under this 2025 Act for the authorized use.

- Sec. 28. (1) The OBDD Economic Development Distributions Fund is established in the State Treasury, separate and distinct from the General Fund. Interest earned on the moneys in the OBDD

Economic Development Distributions Fund must be credited to the fund. SECTION 52. This 2025 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect July 1, 2025.

A RESOLUTION AUTHORIZING THE CITY OF JOHN DAY TO APPLY FOR AND ENTER INTO A LOAN AGREEMENT WITH THE CLEAN WATER STATE REVOLVING FUND (CWSRF) FOR THE WASTEWATER TREATMENT PLANT PROJECT

WHEREAS, the City of John Day recognizes the need to improve and upgrade its wastewater treatment plant to meet current and future environmental, regulatory, and operational standards; and

WHEREAS, the City of John Day is eligible to apply for financial assistance through the Oregon Clean Water State Revolving Fund (CWSRF), administered by the Oregon Department of Environmental Quality (DEQ), which provides low-interest loans for water quality improvement projects; and

WHEREAS, the City Council finds it in the best interest of the City to apply for such financial assistance to support the planning, design, and construction of wastewater infrastructure improvements; and

WHEREAS, the City of John Day intends to request a loan in the amount of **thirty million dollars (\$30,000,000)** through the CWSRF program to finance the wastewater treatment plant project;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JOHN DAY:

- 1. Authorization to Apply: The City of John Day is hereby authorized to apply for a CWSRF loan through the Oregon Department of Environmental Quality in the amount of \$30,000,000 to fund the planning, design, and construction of wastewater treatment plant improvements.
- 2. Authorization to Enter Agreement: The City Council authorizes the City to enter into a loan agreement with the Oregon DEQ through the Clean Water State Revolving Fund for the aforementioned amount.
- 3. Designated Representative: The City Manager, or their designee, is authorized to prepare, submit, and execute the CWSRF loan application and any related documentation, and to act as the City's authorized representative in all matters related to the loan process.
- 4. Effective Date: This Resolution shall take effect immediately upon adoption.

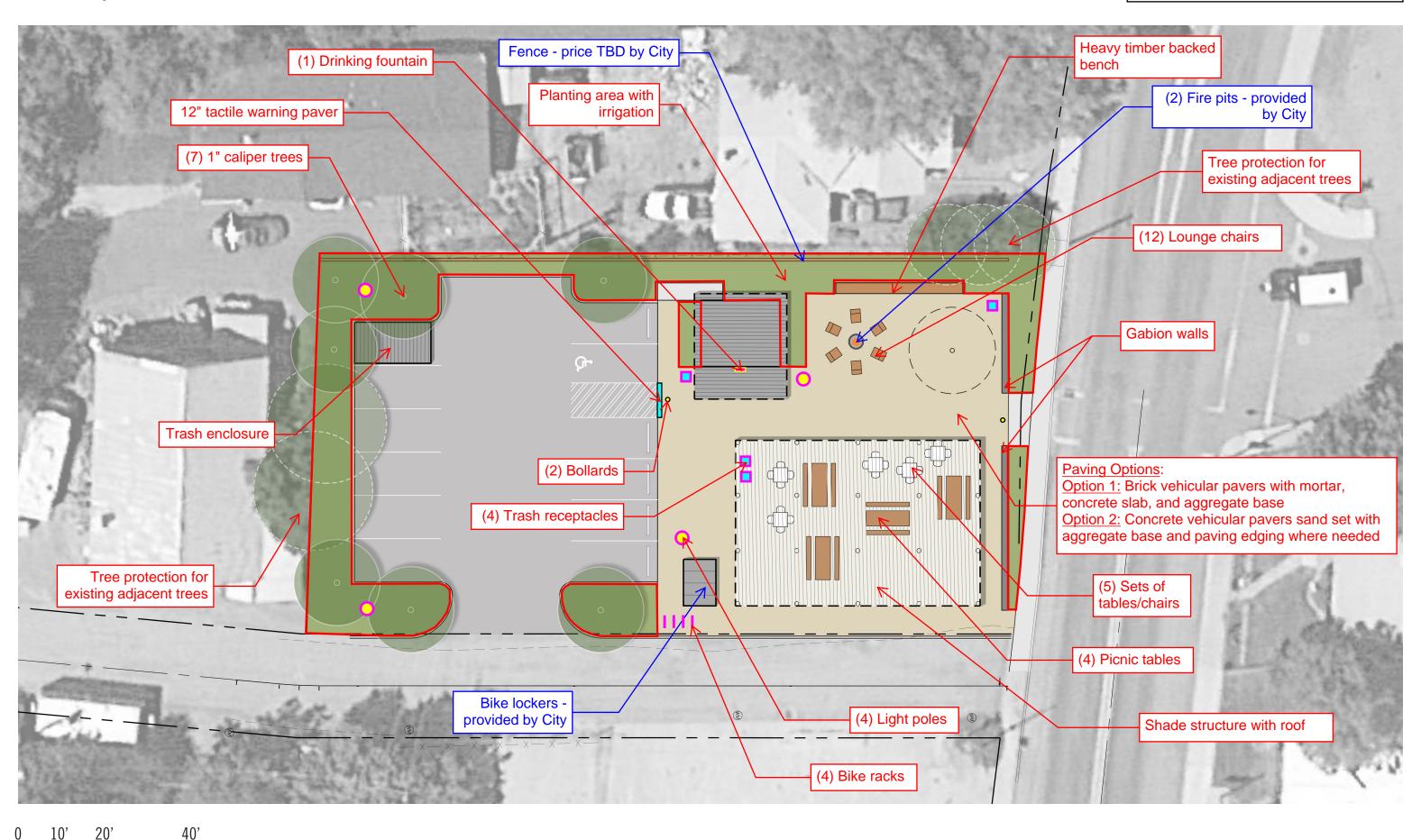

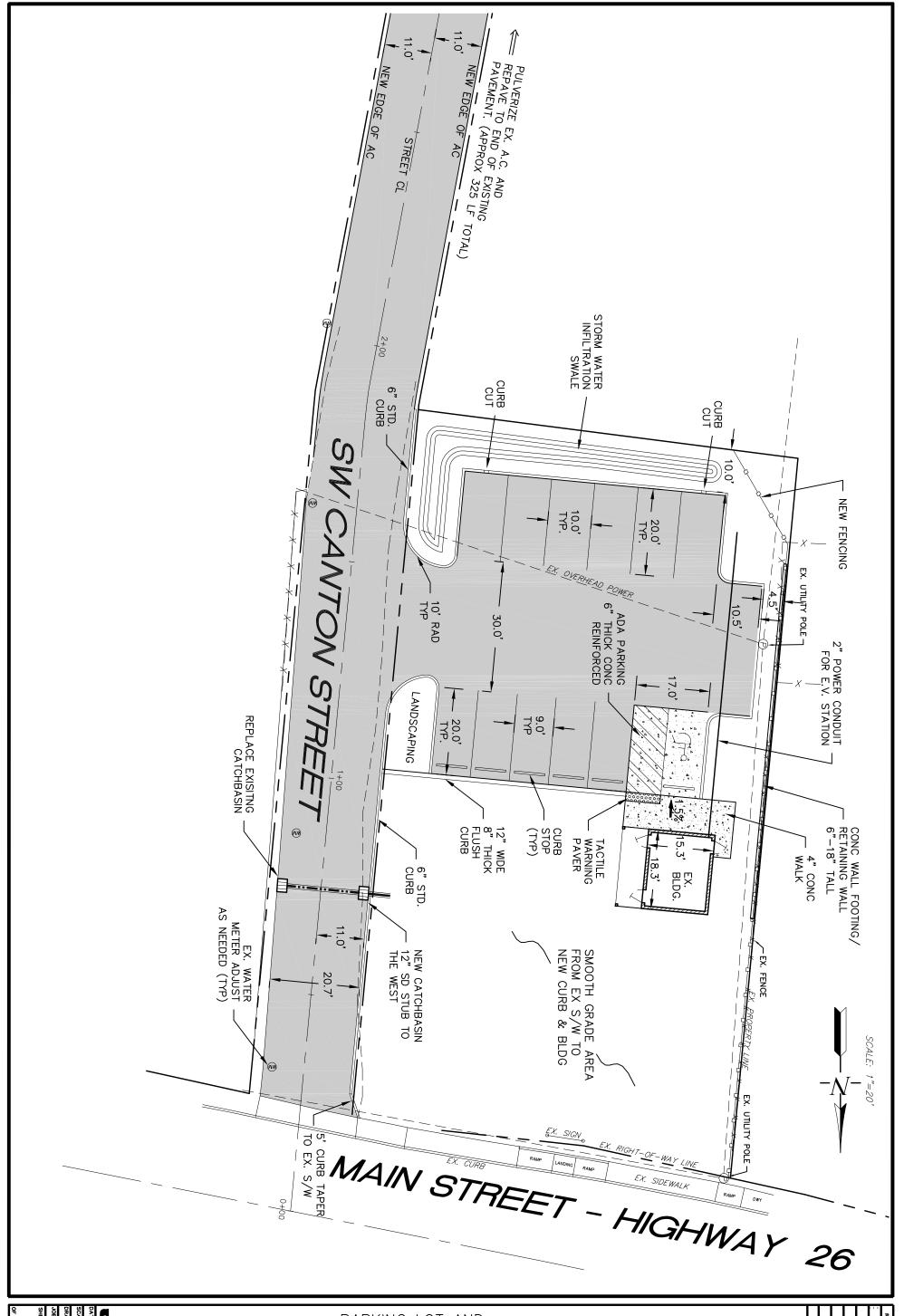

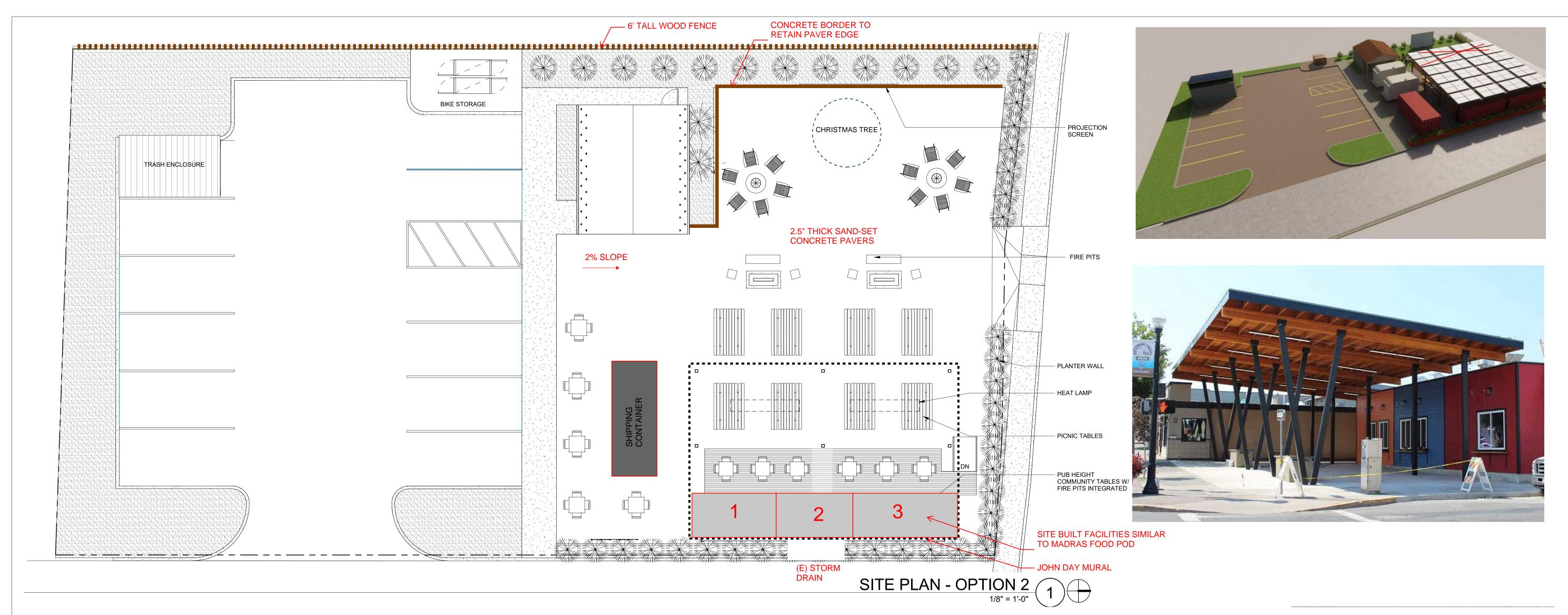
In Oregon, for any new or increased local transient lodging tax (TLT) imposed after July 1, 2003, at least 70% of the net revenue (after collection fees) must be used for "tourism promotion or tourism-related facilities. According to ORS 320.350(6), funds in this category **do not** apply to signage or ongoing maintenance. Therefore, the 70% portion lodging tax dollars would not be eligible for improvements. However, Community dollars (30% collected) would be eligible.

SUBJECT: Discussion regarding policies and procedures with regards to the community grant applications and awards.

BACKGROUND: Under ORS 320.300–320.350, Oregon cities, counties, and other local governments may impose a local Transient Lodging Tax (TLT) on short-term rentals (e.g., hotels, motels, vacation rentals, campgrounds) for stays of less than 30 days.

Key Provisions:

- Maximum Tax Rate: No state-imposed cap on local TLT rates, but any new or increased rate must follow certain requirements. The City of John Day currently imposes a tax of 3%.
- Distribution of Revenue: (Oregon Legislation was looking at HB3962 which would change the percentage/and or allow the funds to be used on infrastructure or law enforcement needs- however, the bill ultimately died.)
 - At least 70% of new or increased TLT revenue must be used for tourism promotion or tourism-related facilities.
 - o The remaining up to 30% may be used for general government purposes.

During the FY24-25 John Day set up a community grant application process to grant the 30% unrestricted funds (\$10,500 budget) to nonprofits or community groups. For FY25-26 the 30% unrestricted funds are budgeted at \$25,756. Since implementing the grant program certain policy questions have surfaced which need council input.

Ouestions for consideration:

- a. Does the Council want to continue the grant program?
 - i. If not: Where would Council like to direct the approximately \$25,000 in funds?
 - ii. If so:

Should there be a cap on how much funding can be requested? Should there be a limit on how often groups can request funding?



Should there be parameters/restrictions on how the funding is utilized by the grant recipient? Should there be a report given to council on the use of the funds showing a measurable outcome by the grantee?

Any other discussion?

FINANCIAL IMPACT: Financial impact depends on the discussion above.

Tourism / Community Grant Applications may be submitted to the City of John Day by any non-profit organization at any time throughout the year. Funds will be allocated by approval of the City Council and as available.

The John Day City Council will review all applications, schedule proposal presentations, and conduct site visits, as appropriate. The City Council will then discuss the various proposals and based on budgetary restrictions fund the projects it deems most advantageous to the city as a whole.
