He noted the reason for the dimensions is that the city anticipates future additions but no new development is currently being proposed. Green added the code stipulated that application for land partitions greater than one acre be reviewed by the planning commission but going through the findings, it was very straightforward without area for discretion and suggested it should be a Type 1 review. He concluded that he may come back to the commission with a code amendment in the future. Green then further reviewed the criteria included in the staff report, the majority of which were not applicable. Mike Springer noted he was present to try to answer any questions the commission may have but was not directly representing the county in the matter. Chairman Boethin asked if anyone present wished to be heard in regards to the matter, either for or against. None appeared. Chairman Boethin closed the public hearing at 12:03PM and opened up for discussion among members of the Planning Commission. There were no comments from the commission.

Commissioner Tim Unterwegner moved to approve Land Partition Application LP-18-03 based on the findings and subject to the conditions of approval contained in the staff report. The motion was seconded by Commissioner Neale Ledgerwood and passed unanimously.
